- a) Fire Chief Report

Rob McWilliam reported on activities since December 10th. The Fire Department responded to a structure fire on Paxton Road; 9 members attended. The Fire Chief met with the Van Anda Chief to go over the reporting requirements as a great deal of paperwork is required. A lift assist request at the airport was also responded to; a question was posed as to whether the Fire Chief thought this system was working. His answer was yes, the turbo flares are working well and they are fully compliant with what is required. The membership is currently at 20 Fire Fighters.

b) Water Operator Report

Ken Taylor gave a verbal report. Ken also commented on the structure fire and his appreciation for the new process of communication between the Fire Department and the Water Operator. This communication allows the Water Operator to monitor the chlorine and keep the community off a boil water alert. Ken reported that there were no issues due to the power outage from the recent weather

storm. The generator at the Fire Hall did not automatically start though. Rob has asked Aaron to look at it.
