#### a) Fire Chief Report

### 5. New Business.

- a. Auditor meeting: chuck, Larry, Theresa and Carol met with Dwayne Dunn of DMD Chartered Professional Accountants. Chuck relayed that the discussion was good, and Dwayne told us they would not have to do a site visit this year, which is a cost savings for the GBID.
- **b.** Res Eau agreement and resolution: A resolution on whether to enter into a collaboration partnership with Res Eau CMI was presented to the Trustees

**c. Water Extension Committee:** Doug Nikirk presented a proposal to extend the GBID water lines along Gillies Bay road to the boundary of Shelter Point Park.

Motion to approve in principle, the water extension project pending the approval of the water license application, moved and seconded by the Board of Trustees CARRIED

Chuck commented that he liked all the work that was done; the numbers are realistic. This may expedite the water license. A question on water flow was asked. An engineer will need to sign off on the project. We can also ask Res Eau. Doug will contact the qRD and ask them once again if they would like to be included in the expansion.

d. Water extension committee new member approval

Motion to approve Rolly Thorpe joining the committee, moved and seconded by the Board of Trustees

e. Log Boom: Mike presented a report and draft price list for logs and materials needed for the log boom. The Dam Inspector and VCH will be contacted for feedback and approval of the plan. The spillway and possibility of moving the intake also need to be looked at. The Water Quality Committee will look at the log boom, spillway and intake and make a recommendation to the Board.

Motion to accept the Log Boom report, and move forward to consult with the dam engineer and also with Res Eau regarding the intake, moved, and seconded by the Board of Trustees CARRIED
